Welcome and Introduction

Due to a lack of a quorum present during this meeting, it was recommended that the minutes from April 21, 2014 Executive meeting be presented to the Executive meeting members for approval during the upcoming Full OASAC Meeting scheduled for November 17, 2014.

PA-Consumer Directed Workgroup Update

During the first PA Workgroup meeting a grid for the analysis of the application of the PA/Consumer Directed Principles across State programs was created. This grid includes the following PA models: Developmental Disabilities (D/D), Division of Rehabilitation Services (DRS), IDoA Agency with Choice and Cash and Counseling. The OASAC PA Workgroup agreed to make recommendations for PA/Consumer Directed Services using the following principles: Person-Centered Planning, Consumer Protections, Oversight & Monitoring, Capacity Assessment,

Training, Background Check, Consumer Awareness of Choice, and Flexibility for participant to use Agency and/or Personal Attendant in their plan of care, and Workforce protections. The purpose of the PA Workgroup was discussed which is to review the issues around the Personal Assistant (PA) self-directed home and community based service and to make recommendations to the State with regard to this service as it pertains to the 1115 waiver proposal. OASAC PA workgroup membership was reviewed; a CILS representative and two consumer representatives have been added to the Workgroup. It is the intent of the workgroup to look at existing services and Person-Centered Planning (PCP). The goal of the PA Workgroup is to have a verbal presentation of the recommendation for the Full OASAC meeting scheduled for November 17, 2014.

It was advised that the PA Workgroup should place a focus on training; how the requirements of Person-Centered Planning are being met; what Person Centered Planning is; educating the consumer in making choices; training the providers to engage consumers and family members. There have been many internal and stakeholder meetings regarding the discussion of the Person-Centered Planning care plans. Phyllis advised to read a book titled *Being Mortal: Medicine and What Matters in the End* by Atul Gawawnde which was written by a physician who discusses long term care and aging.

OASAC Report

The OASAC 2015 Report to the General Assembly will be streamlined this year. The first draft has been shared internally with sister agencies. The updated draft will be shared during the Full OASAC Meeting scheduled for November 17, 2014. The OASAC 2015 Report to the General Assembly includes information on the presentations/discussions on the initiatives that were offered during the Full OASAC meetings. Feedback for this report will be requested from OASAC. Recommendations from the PA Workgroup regarding the PA-Consumer directed model, and the recommendations developed by OASAC for a stakeholder engagement process will also be included in the OASAC 2015 Report.

Other Updates

A draft version of the Consumer Bill of Rights that is relevant to the Person-Centered Planning Process is available for stakeholder feedback. The Consumer Bill of Rights will be applied to all consumers receiving home and community based services not just Department on Aging and Department of Rehabilitation Services. It will be an overarching Bill of Rights that can be used in conjunction with other program specific agency rights. A draft version of the service definitions that the State Agencies have been working on is also available for stakeholder feedback.
