SUBJECT: INFORMATION POSTED PURSUANT TO THE FREEDOM OF INFORMATION ACT ("FOIA")

This memorandum is posted pursuant to the Illinois Freedom of Information Act (5 ILCS 140) and contains the following information:

- I. A description of the Illinois Capital Development Board ("CDB"), including the identification of CDB's Board Members, a block diagram outlining its subdivisions, the total amount of its operating budget, the location of its satellite offices, and the approximate number of full and part-time employees.
- II. A description of the methods whereby the public may request information and public records from CDB, including the name of CDB's designated FOIA Officer, the address where requests for public records should be directed and any fees allowable under FOIA.
- III. Fee Schedule for Records.

I. DESCRIPTION OF THE ILLINOIS CAPITAL DEVELOPMENT BOARD

Enacted under the Capital Development Board Act (20 ILCS 3105), the Capital Development Board ("CDB") is the construction management agency for Illinois state government. CDB oversees the construction of new state facilities, such as prisons, college and university classroom buildings, mental health hospitals and state parks. In addition, CDB is responsible for renovation and rehabilitation projects at the State's 8,441 state-owned buildings containing more than 96 million square-feet of floor space.

The agency also works with the Illinois State Board of Education to administer grants for school construction and renovation to local elementary and secondary school districts through the School Construction Program. In addition to its construction duties, CDB also is responsible for the removal of hazardous materials such as asbestos and lead from state-owned facilities, the replacement of leaking underground storage tanks on state property and the remodeling of state buildings to accommodate persons with disabilities.

Established to better manage the state's capital improvement programs, the agency is guided by a seven-member, bi-partisan board that deliberates matters of policy, approves the selection of design professionals through the 1991 Qualifications-Based Selection System and sets direction for the agency. The board members, who are appointed by the Governor and confirmed by the Illinois Senate, serve four-year, unpaid terms. They also are charged with selecting an executive director, who is responsible for the daily operation and management of the agency and its employees. Board members are as follows:

James Reilly - Chairman

Governor Bruce Rauner appointed former State Representative James Reilly as the Chairman of the Capital Development Board in April 2015. Reilly brings decades of experience in public sector development. Reilly is the former CEO of the Metropolitan Planning and Exposition Authority (MPEA), where he oversaw operations and policy. He held the position twice, from 1989-1999 and from 2012-2015. He has overseen the redevelopment of Navy Pier, expansion of McCormick Place and development of the Hyatt Regency McCormick Place. He also served as a trustee of the MPEA from 2010 to 2012 before his second tenure as CEO. In between stints at the MPEA, Reilly was a consultant to the hospitality industry at the Reilly Consultant Group. He was also the chairman of the Regional Transit Authority from 2005-2010 and was the CEO of the Chicago Convention and Tourism Bureau from 1999-2004.

Reilly has extensive experience in state government, serving as chief of staff to Governor Jim Edgar from 1994-1995 and for Governor Jim Thompson from 1983 to 1989. He also served in the General Assembly for six years as a state representative. Reilly earned his bachelor's degree from Illinois College and a law degree from the University of Chicago. He lives in Chicago.

Glyn Ramage

Glyn M. Ramage of Millstadt was named to the Capital Development Board in August, 2002. He was appointed acting chairman of the CDB between February and April of 2004. Member Ramage has served as the business manager for the Twelve Counties Southwestern Illinois Laborers District Council since 2000. He is a 26-year member of the Laborers' Local No. 100 in East St. Louis and has served as business manager of the Local since 1993.

Member Ramage serves as chairman of the Foundation for Fair Contracting of Southwestern Illinois, Inc. and is a director of the Labor Management Work Preservation & Construction Industry Promotional Trust of Southwestern Illinois.

Miles W. Beatty III

Miles W. Beatty III of Lake Zurich, President of Beatty Decorating Company, was named to the Capital Development Board in January of 2012.

Beatty has been president of Beatty Decorating Company, a firm that specializes in painting, wall coverings and specialty finishes, since 1992. He joined the family-owned firm as an apprentice in 1972. He is on the Board of Directors of the Finishing Contractors Association of Chicago and is a Trustee of the Chicago Painters and Decorators Pension Fund.

Beatty has been an Illinois resident for 59 years. He and his wife Pam have three adult children.

William A. “Bill” Lowry, Sr.

William A. “Bill” Lowry, Sr. was named to the Capital Development Board in May 2014. He is President and Managing Shareholder of Nyhan, Bambrick, Kinzie & Lowry, P.C., a Chicago law firm with 47 attorneys. His specialty is in Workers' Compensation and Employer Liability Law. Bill has received numerous professional recognitions, including being named among Chicago’s Best Lawyers. He is the author of several legal articles and presents lectures at seminars relating to insurance and employment law. Bill is a board member of Lake Forest College, Loyola University of Chicago School of Law, Chicago Children’s Museum, Chicago Family Directions, Legal Prep Charter Academies, Coordinated Advice and Referral Program for Legal Services and The Ancona School.

Steven Orlando

Governor Bruce Rauner appointed Steven Orlando to the Capital Development Board in April 2015. Orlando brings a marketing and insurance background to the board. Currently, Orlando is the Vice President of Sales for the Candos Agency, which is an insurance and financial services agency. He has worked for the agency since 2005 and markets health insurance and other benefits to small employers and individuals. Prior to the Candos Agency, Orlando worked for Heartland Blood Centers as a marketing representative. He assisted churches, businesses and high schools with blood drives by recruiting donor and supplying prizes and gifts. Orlando also worked at Farmers Insurance for nearly three years as a personal lines underwriter. Orlando earned his bachelor’s degree from Northern Illinois University. He lives in Plainfield.

Pamela McDonough

Pamela McDonough of Chicago was named to the Capital Development Board in November, 2015. She brings more than 30 years of experience in both the public and private sectors to the board.

McDonough is the President of the DeAngelo McDonough Construction Management Company. She has been with the construction management company since 2003. She also serves as President of McDonough Enterprises, Ltd., which is a business development company that performs technical assistance and association management for not-for-profits. Before this work, McDonough served as the first woman director of the Illinois Department of Commerce and Community Affairs. Under her leadership Illinois ranked first in the nation for economic development in 2001 and 2002. She also served in many other state government leadership roles including serving as Deputy Director of the Capital Development Board from 1992 to 1995.

McDonough is an active member of the community. She sits on the Affirmative Action Advisory Board, the Federation of Women Contractors Board, the Women’s Business Development Center Board and the Wilbur Wright College President’s Advisory Committee.


McDonough earned her bachelor’s degree from Northeastern Illinois University and earned a Master’s in Public Administration from Sangamon State University. She lives in Chicago.

Governor Bruce Rauner has appointed Jack Carney to the Capital Development Board in February 2016. His experience in construction and construction management will bring a valuable perspective to the position.

Carney previously managed ASC Construction, a heavy construction company in Boise, Idaho that specialized in dams, power houses, pulp and paper mills, and industrial projects. Carney was previously the President of Gray International and the VP of the Western Region at Morrison-Knudsen.

Carney holds a bachelor’s degree from Arizona State University. He lives in Arlington Heights.

CDB does not accept FOIA requests via telephone. Facsimile requests will be honored at 217-524-0565 and e-mail requests will be honored at CDB.FOIA@Illinois.gov.

When submitting a FOIA request, please be as specific as possible and clearly describe the documents being sought, or documents you wish to inspect, including the project/contract numbers and a description of the project if applicable. Please include your name, affiliation, address and phone number.

Upon receipt of your request, the FOIA Officer will review your request and respond within 5 working days of receipt of the request. Responses may include but are not limited to a full disclosure of documents, a disclosure of documents with certain information redacted, a notification that CDB needs up to an additional 5 working days to respond, or a denial or partial denial of your request due to certain exemptions under the Act.

CDB may charge fees reasonably calculated to reimburse its actual cost for reproduction and for the use by any person of the equipment of the public body to copy records. CDB may waive fees if “the person requesting the documents states the specific purpose for the request and indicates that a waiver or reduction of fee is in the public interest” in accordance with 5 ILCS 140/6 (c).
