Emergency Justification:	The roof has leaked for three years, and a tarp was installed after no repair moneys were made available. The tarp is not a completely effective barrier to water leaks, and is very unlikely to last through the winter. Water leaks impact food handling and food safety, and would damage the interior of the facility. CDB's processes for competitively procuring an A/E, who would then prepare detailed bidding documents, and then procure a roofing contractor would not lead to repairs being implemented much sooner than March 2014. The roof is likely to develop serious leakage prior to that time.
