The enclosed information fulfills the statutory directive that the Illinois Department of Commerce and Economic Opportunity (DCEO) report annually to the members of the Illinois General Assembly on the status of the Illinois Angel Investment Tax Credit Program.

The Illinois Angel Investment Tax Credit Program officially became effective on January 1, 2011. The purpose of the Angel Investment Program is to attract and encourage the placement of investment dollars into early-stage, innovative companies throughout Illinois. The investment dollars provide these companies with much needed access to working capital to further their growth and success in our state.

I trust you will find this 2012 Angel Investment Tax Credit Program Report useful.

I. Introduction

The Illinois Angel Investment Credit Program is designed to encourage interested firms or individuals to make an investment in one of Illinois' innovative, qualified new business ventures. The investment will encourage job growth and expand capital investment in Illinois. The program can offer a tax credit to qualified investors in an amount equal to 25% of their investment made directly in a qualified new business venture. The maximum amount of tax credits to be issued under the Act is capped at \$10,000,000 per calendar year. The program will be administered for the taxable years beginning after December 31, 2010, and ending on or before December 31, 2016.

The Angel Investment Program has two sides of participation; interested Illinois Businesses must apply to DCEO each taxable year for which the business desires registration, and their investors must submit an application to DCEO when an investment is placed into the qualified new business venture in order to be considered for a tax credit. The claimant must keep their investment in the qualified new business venture for no less than 3 years.

Effectiveness:

In only its third year of existence, the Angel Investment program has aided in the placement of nearly \$50 million dollars into many early-stage, innovative businesses throughout Illinois.

In 2011, the Angel Investment Program utilized just \$2 million of the available \$10 million in tax credits. This was mainly due to the fact that it was the first year of the program and it took time to communicate this program offering to the business community and only after businesses were registered, could we then accept and consider investor applications. However, the businesses that were registered during the Program's first year placed over \$22 million in the State of Illinois in capital investments throughout 2012, which means that for every dollar spent on tax credits, eligible Angel businesses placed an average of ten dollars of capital investment into Illinois.

During 2012 over ninety nine businesses were registered with the Program. Of those ninety nine businesses, forty eight received investment dollars. Moreover, over three hundred investors received tax credit certificates as a result of investing their funds into Program certified businesses, providing much needed capital to Illinois start-up businesses.
