

SUBMISSION NOTICE OF ENTERPRISE ZONE DESIGNATION APPLICATIONS

Purpose: Provide proposed Enterprise Zone residents, businesses, civic and other organizations an opportunity for written comment regarding submission

On or before December 31, 2015, the Illinois Department of Commerce and Economic Opportunity (“IDCEO”) received 18 application submissions seeking designation as a new Enterprise Zone to commence January 1, 2017 and continue up to 25 years. Each application has a proposed Enterprise Zone Area that consists of all or part of the governmental unit and is less than 15 square miles. The Enterprise Zone application is available for public inspection. You may contact IDCEO for the exact location of your unit’s application at 217-524-0165. All of the Enterprise Zone applications met the minimum qualifying criteria. Selected applicants can receive Enterprise Zone benefits which include: the Utility Sales Tax Exemption, Expanded Manufacturing Machinery & Equipment Sales Tax Exemption, Business Investment Tax Credit of 0.5%, and Building Materials Sales Tax Exemption (residential and business).
