RE: Notice of Sanction: \$100,000 Financial Penalty

Dear Dr. Whitaker:

This letter serves as notification to NextLevel Health Partners ("NextLevel") of sanction pursuant to Section 7.16.6 of the Contract for Furnishing Health Services by a Managed Care Organization ("contract") between the Department of Healthcare and Family Services ("Department") and NextLevel:

"7.16.6 Failure to submit Encounter Data. The Department and Contractor acknowledge and agree that they will work in good faith to implement mutually agreed-upon system requirements resulting in the complete and comprehensive transfer and acceptance of Encounter Data, and that such mutual agreement shall not be unreasonably withheld. Contractor shall submit complete and accurate data quarterly to the Department in accordance with the Illinois Medicaid Health Plan Encounter Utilization Monitoring (EUM) requirements document, as set forth in Attachment XXIII, for each evaluation period. If Contractor does not meet the standards by the evaluation date as set forth in Attachment XXIII, the Department, without further notice, may:

7.16.6.1 impose a monetary penalty of up to US \$100,000;

7.16.6.2 impose an enrollment hold on Contractor; or

7.16.6.3 impose both."

NextLevel's overall score of 93.81% for its HealthChoice Illinois contract in the Encounter Summary Report for EUM 2019 Evaluation Period 2 was below the 96% threshold related to the \$50,000 Financial Penalty outlined in Attachment XXIII. Additionally, NextLevel's scores of 67.25% for the Transportation and 83.90% for the Encounter Rate Clinic categories were below the 85% threshold related to the \$50,000 Financial Penalty outlined in Attachment XXIII. The Department is hereby providing written notice that NextLevel failed to meet the established expectation and is therefore fining NextLevel in the amount of \$100,000. NextLevel is to issue a check payable to the Department of Healthcare and Family Services for \$100,000. In the memo section of the check, please indicate "Re EUM 2019 Eval 2".
