THIS MATTER COMING on to be heard under the Prevailing Wage Act, 820 ILCS 130/0.01-12 and Notice of Hearing issued there under, and, pursuant to 56 Illinois Administrative Code 120.400 (a) (1-6) all parties having been duly advised on the premises;

IT IS HEREBY ORDERED:

1. On or before October 21, 2014, the parties and intervenors shall provide all parties and intervenors copies of any and all documents that it may offer into evidence at least 21 days prior to the scheduled hearing date. Documents already provided, need not be provided again. Each party shall provide newly discovered documents, as the documents become known to the party or intervenor who is intending to introduce the document.
2. On or before October 21, 2014, each party and intervenor shall provide to all parties and intervenors a witness list containing the name and address of any witness who may be called to testify. Each party or intervenor shall provide newly discovered witnesses as they become known to the party intending to call the witness.

3. The hearing on this matter is scheduled for November 13 and 14, 2014 at 9:30 a.m. at 160 N. LaSalle St., Ste. C-1300, Chicago, IL 60601. Entrance into the building requires presentation of valid government issued photo identification and security screening.
