THIS MATTER COMING on to be heard under the Prevailing Wage Act, 820 ILCS 130/0.01-12 and Notice of Hearing issued there under, and, pursuant to 56 Illinois Administrative Code 120.400 (a) (1-6) all parties having been duly advised on the premises;

IT IS HEREBY ORDERED:

1. Any and all individuals or organizations interested in being granted party status in this hearing shall file a Petition to Intervene on or before August 19, 2014. Said petition shall be filed with the undersigned by said date and served upon all individuals listed in the attached certificate of service. Any Petitions received after that date will be dismissed as causing undue delay in the adjudication of the rights of the original parties. All Petitions to Intervene shall comply with 56 Ill. Adm. Code 120.320. Failure to file the Petition in accordance with 56 Ill. Adm. Code 120.320 will result in the Petition not being in compliance with this order and subsequent denial.
2. A pre-hearing conference shall be convened via telephone on August 14, 2014 at 1:30 p.m. to simplify the issues, determine necessity or desirability of amendment to documents for purposes of clarification, simplification or limitation, determine stipulations, admission of fact and of contents and authenticity of the documents, limit the number of witnesses, determine propriety of the prior mutual exchange among the parties who have prepared testimony or exhibits, and decide other matters as may tend to expedite the disposition of the proceedings and to assure a just conclusion thereof.

3. Any and all attorneys who have not filed an appearance shall also file said appearance on or before.
4. Any party or potential intervener desiring to participate via telephone shall notify the undersigned and all individuals list in the certificate of service by August 12, 2014. The party or potential intervenor shall also furnish a telephone number at which to be reached.
5. Entrance into the building requires presentation of valid government issued photo identification.
