Liquor Control Commission February Underage Compliance Report

SPRINGFIELD – In **February** the Illinois Liquor Control Commission (ILCC) conducted compliance checks around the state and visited 134 businesses licensed to sell liquor. They cited 35 licensees for violations of liquor control laws. Seventy-four percent of the licensees visited complied with Illinois liquor laws and refused to serve underage customers.

This report is a result of ongoing undercover and cooperative law enforcement operations conducted by Illinois Liquor Control Commission (ILCC) agents and local law enforcement officials and volunteers from high schools and colleges. The teams randomly visit liquor stores, restaurants and bars in communities around the state to check for ongoing compliance with state laws mandating that no liquor is sold to minors under the age of 21. ILCC agents also work with local and state law enforcement agents to focus on communities with a high incidence of underage liquor sales.

Champaign – On February 16th, 2012 the ILCC and the Champaign Police Department conducted underage alcohol compliance checks in Champaign. Of the 27 checks made, eight licensees sold alcohol to ILCC underage participants. Those licensees were:
