SCHEDULING ORDER


At its June 20, 2012 Hearing, the State of Illinois Liquor Control Commission (“Commission”) announced the following schedule of proceedings with respect to the Citations identified above:

1. All Motions to be filed by the parties shall be filed by July 18, 2012. (For purposes of these proceedings, the Illinois Liquor Control Commission, as represented by its Chief Legal Counsel, Richard R. Haymaker, City Beverage LLC, City Beverage – Markham, LLC, Chicago Distributing LLC, and Wholesaler Equity Development Corporation shall be considered the “Parties” to these proceedings.)

2. Any Responses to the Motions shall be filed by the Parties by July 27, 2012.
3. These Proceedings are scheduled for further hearing at the Commission's August 8, 2012 Meeting at 1:30 p.m.
4. If the Commission determines that oral argument on the Motions are to be heard, oral arguments on the Motions shall be made at the Commission's August 8, 2012 Meeting.
5. The Commission shall hold a pre-hearing conference at 9:00 a.m. on August 8, 2012, at which time the Parties shall be required to identify all witnesses, documents, and other evidence they intend to call or submit at the Hearing, and generally discuss their plans for the Hearing.
6. Persons or entities other than the Parties that might be interested in submitting a memorandum on the issues raised by these proceedings shall serve on the Commission a Notice Of Intent To File Memorandum by August 8, 2012.
7. The Parties shall file Stipulations of Fact by August 22, 2012.
8. Each Party shall file a Memorandum, limited to fifteen pages, in support of its position by September 7, 2012. The Commission expects that City Beverage LLC, City Beverage - Markham, LLC, and Chicago Distributing LLC shall file one combined Memorandum limited to fifteen pages.
9. A person or entity other than a Party that has filed a timely Notice of Intent to Submit Memorandum may submit a Memorandum on the issues raised by these proceedings, limited to fifteen pages, by September 7, 2012.
10. If a Party wishes to file a Response to another Party's Memorandum, such Response, limited to fifteen pages, shall be filed by September 21, 2012. (The Commission will not accept or consider Responses filed by anyone other than a Party).
11. A Hearing in these proceedings is scheduled for October 1, 2012, to be continued to October 2, 2012, if necessary.


