

YEAR IN REVIEW

The Illinois Racing Board, an independent agency of state government, enforces the Illinois Horse Racing Act of 1975 (230 ILCS 5/) and its administrative rules (Title 11 of the Administrative Code), to ensure the safety and integrity of pari-mutuel horse racing in Illinois. The Illinois General Assembly establishes public policy in the area of horse racing regulation that is enforced by the Board. The Board licenses racetracks, off-track wagering (OTB) facilities, and advance deposit wagering companies, allocates race dates, and is also responsible for licensing, rulemaking, and supervising the conduct of race meets. The Board also oversees all pari-mutuel activity and ensures the proper allocation and distribution of revenue generated by pari-mutuel wagering.

Every participant in Illinois racing is required to obtain an occupational license. Before a license is issued, every application is reviewed and carefully processed by the Board's licensing department. Also, by statute, fingerprinting is required of each applicant. The Board issued 7,548 licenses during 2013, down 3%, compared to 7,767 in 2012.

A staff of administrative, regulatory, security, and veterinary professionals, in conjunction with Board approved racing officials, supervised the activities at five racetracks conducting pari-mutuel horse racing. Each race conducted at an Illinois racetrack is observed by three stewards, two employed by the Board, one employed by the racing association. The stewards observe the races to ensure that all conduct is in accordance with the rules and regulations.

The Illinois Horse Racing Act of 1975 requires the Board to file a written annual report with the Governor. The report shall include the industry's progress toward the following policy objectives established in Section 1.2 of this Act:

1. *Support and enhance Illinois' horse racing industry, which is a significant component within the agribusiness industry.* Sections 30 and 31 of the Horse Racing Act promote the breeding,

buying and racing of thoroughbred and standardbred horses in Illinois, preserving the agribusiness segment of the state's economy. Purse supplements, owners awards, and breeders awards are paid to owners and breeders of winning horses in certain races limited to Illinois conceived and foaled horses.

2. *Ensure that Illinois' horse racing industry remains competitive with neighboring states.* Through the rulemaking process established by the Illinois Administrative Procedure Act and supervised by the Joint Committee on Administrative Rules, the Board creates new rules and amends existing rules to be more uniform and consistent with other major racing jurisdictions. In recent years, the Board has concentrated on rules regulating wagering, medication, and claiming.

3. *Stimulate growth within Illinois' horse racing industry, thereby encouraging new investment and development to produce additional tax revenues and to create additional jobs.* The Board strives to foster an environment that creates jobs and generates important revenue to the State of Illinois by encouraging racetracks to make use of their vacant off-track wagering licenses. Each racetrack is entitled to receive up to six OTB licenses, except Fairmount Park, which is entitled to seven licenses. A total of 37 licenses are available.

4. *Promote the further growth of tourism.* To ensure that adequate funds are devoted to the marketing of horse racing, the Board requires that each applicant for licensure to operate a race meet, submit a proposed advertising and promotional budget during the licensing process.

5. *Encourage the breeding of thoroughbred and standardbred horses in this State.* Pursuant to the Horse Racing Act, breeders awards have been established to promote the breeding of thoroughbred and standardbred horses by Illinois residents.

6. *Ensure that public confidence and trust in the credibility and integrity of racing operations and the regulatory process is maintained.* Public

confidence is essential to a vital horse racing industry. The licensing of all persons participating in pari-mutuel racing and the testing of post-race equine samples are necessary components of the Board's regulatory program. Urine and blood samples are obtained post-race from the winner of every race, the horses finishing second and third in stakes races, and from any other horses selected at random by the stewards.

The Board is a member of the Association of Racing Commissioners International (RCI), the industry's oldest and most prominent regulatory association. Executive Director Marc Laino serves as Chairman of the Wagering Security Systems Committee. The information contained in the RCI database allows the Board to monitor the backgrounds of licensees and to exchange important regulatory and industry information with other jurisdictions.

The horse racing industry in Illinois continued to struggle. In 2012, the Illinois handle on all racing was \$672,902,966. In 2013, the handle was \$617,943,710, down 8%. In 2012, the total handle for advance deposit wagering (ADW) on all racing was \$122,167,920. In 2013, the handle was \$75,936,632, down 38%. The reason for the major decline was the expiration of advance deposit wagering on December 31, 2012, which was not re-authorized by the Illinois General Assembly until June 7, 2013.

The Board continued to struggle with fiscal and budgetary issues. The Board is funded by the revenues generated from the pari-mutuel handle (including ADW), admission taxes and license fees. The Board receives no funding from the State's General Revenue Fund. As the handle decreased, the Board's revenues declined. In 2012, total taxes paid to the Board were \$6,631,273. In 2013, taxes paid were \$5,706,988, down 14%. The main reason for the decline in revenues was the absence of advance deposit wagering for the first five months of 2013.

Due to the uncertainty of funding available in 2014, the Board, at its Dates Hearing on Sep-

tember 24, 2013, was compelled to issue a full racing schedule for 2014, contingent upon events occurring which would restore funding to adequate levels, and three alternative reduced racing schedules in the event certain funding options did not materialize. The three alternative schedules concentrated the race date reductions among the applicants generating the least amount of money in pari-mutuel and admission taxes for live racing.

A total of \$72,036,761 was distributed in purses in 2013. Thoroughbred owners, jockeys trainers received \$48,359,376 in purse money and standardbred owners, drivers and trainers received \$23,677,385. In 2012, a total of \$78,515,048 was distributed in purses, \$54,189,232 to thoroughbred and \$24,325,816 to standardbred.

During calendar year 2013, the Board amended rules to protect the wagering public and ensure the safety of the participants, both human and equine. The Board issued 629 rulings for violations of the Board's rules and regulations at both thoroughbred and standardbred racetracks. The rulings include, but are not limited to, riding and driving infractions, general conduct violations, licensing violations, human and equine drug violations, and general business practice violations.

King Mufasa was voted 2013 Illinois Harness Horse of the Year. He was also voted 3-year-old champion male trotter. Owned by Bill Wright and Mystical Marker Farms and trained by Mike Brink, King Mufasa earned \$ 238,590 while winning every major Illinois bred stake including the \$124,000 Su Mac Lad on Super Night at Balmoral Park.

Work All Week was voted 2013 Illinois Thoroughbred Horse of the Year. A winner of \$226,266 in 2013, this 4-year-old gelding, trained by Roger Brueggemann, went to the post eight times and recorded seven wins and one second. Owned and bred by Midwest Thoroughbreds, Work All Week won the Lightning Jet Handicap at Hawthorne Race Course and Fairmount Park's Tex's Zing stake.

LABORATORY

Over the past year the University of Illinois at Chicago Animal Forensic Toxicology Laboratory has conducted one of the most comprehensive equine drug testing programs in the country. The laboratory accomplished this by employing an extensive array of enzyme linked immunosorbent assays (ELISA), as well as the state-of-the-art LC-MS-MS systems, to routinely screen samples for prohibited substances. These tests are highly sensitive and allow the laboratory to screen for a wide range of substances. In addition, the laboratory routinely tests for violations of total carbon dioxide (TCO₂) levels by continually updating its TCO₂ analysis which now provides the Board with additional electrolyte information. The laboratory also continued to routinely screen for anabolic steroids in an effort to enforce the Illinois Racing Board regulations.

The laboratory continues to assist the track stewards and security personnel in investigating possible doping violations that employ methods designed to circumvent our standard testing procedures. The laboratory also investigates and reports on special items such as syringes, drug vials and other contraband that are collected or seized at the racetracks.

The laboratory participated in the International Proficiency Testing Program conducted by the Association of Official Racing Chemists, and maintained perfect scores on all proficiencies in 2013. The laboratory is actively seeking the ISO 17025 accreditation and already was initially assessed in order to achieve a full accreditation.







WHAT IS PURSE RECAPTURE?

Purse recapture is a 1995 provision of the law that allows racetracks to recoup losses on live handle brought on by the authorization of full-card simulcasting of races from other states. Handle on Illinois races as a percentage of total Illinois handle has dropped from 95% in 1994 to 24% in 2013. The recapture amount is 2% of the decrease of Illinois handle on Illinois races from 1994. The recapture monies allocated to the racetracks are deducted from the horsemen's purse accounts. In 1999, legislation was passed that authorized annual appropriations to the Department of Agriculture for reimbursement to purse accounts equal to the recapture amounts. The appropriation is an annual decision, the racetracks will always receive their monies, either from the State or from the originally intended horsemen's purse accounts. Below are the annual amounts of purse recapture since 1995, when full card simulcasting was authorized.

2013 ADVANCE DEPOSIT WAGERING (ADW)

Advance Deposit Wagering officially began in Illinois on October 13th, 2009. Four companies were licensed in 2013 as ADW providers. Illinois patrons place funds into an account and then wager on races using a telephone or internet device such as a computer or personal digital assistant. Each ADW provider must have a contract with an Illinois racetrack and their affiliated Illinois horsemen association.

In 2013, Advance Deposit Wagering expired and was not re-authorized until June 7th. Betzotic started operations on July 25th and Youbet contractually ceased operation on October 31st. On January 29, 2014, ADW was re-authorized for three years and included an additional .2% surcharge on winning wagers and winnings from wagers to help fund the Racing Board.
