### Overview

#### Description and Specifications:

The Office of Executive Inspector General for the Agencies of the Illinois Governor (OEIG) is giving notice of intent to award a sole source to Meridian Knowledge Solutions, LLC for a vendor-hosted learning management system (LMS) and custom LMS courseware to enable the State to produce and deliver statutorily required annual ethics training courses to an estimated 51,700 State employees prior to June 30, 2014. This procurement seeks to replace services that furnished to the OEIG under contract number LMS50909, which was cancelled effective November 30, 2013.

A hearing is scheduled for December 26, 2013 at 2:00 pm in 511 Stratton Office Building, Springfield, Illinois 62706. A sole source contract will be awarded on that date and the hearing will be cancelled unless an interested party submits a written request for public hearing by 5:00 pm (Central) on December 20, 2013.

If a public hearing is requested, the purchasing agency shall present testimony justifying the procurement method. Any interested party may present testimony for or against the sole source determination as described in this notice. The purpose of the hearing will be to receive information from the public as to whether award by sole source is appropriate and in accordance with the Illinois Procurement Code. Formal rules of evidence will not apply. Hearings may be recorded in order to aid in the production of minutes. Parties may submit written comments in lieu of attending the hearing. Written comments will be afforded the same weight as oral comments received at hearing.

Interested parties wishing to submit comments or request a hearing must do so in writing and submit their request to the Notice Contact.
