

**PEORIA REGIONAL HUMAN RIGHTS AUTHORITY MINUTES**  
**September 14th, 2011**

The regular stated meeting of the Peoria Regional Human Rights Authority (HRA) was called to order at 1:00pm on Wednesday, September 14th, 2011 by Chairperson Meri Tucker.

The meeting was held at the Kewanee City Hall, 401 East Third Street, Kewanee, IL 61443

**ROLL CALL**

The Chairperson stated that a quorum was present.

The Chairperson stated the personally identifiable information should not be presented in public meetings to protect the privacy of those persons with disabilities on whose behalf the HRA conducts investigations.

Introductions were made.

The motion was made by Flora Knutson to enter closed session at 1:04pm pursuant to Section 120/2 (c) (4) and (10) of the Open Meetings Act (5 ILCS 20), Section 3955/10 of the Guardianship and Advocacy Act (20 ILCS 3955) and Section 110/5 of the Mental Health and Developmental Disabilities Confidentiality Act (740 ILCS 110); the motion was seconded by Meri Tucker and carried. The purpose of the closed session was to discuss confidential information with guests.

The HRA returned to open session at 1:20pm having taken no action in closed session. The motion to return to open session was entered by Dolores Sheen and seconded by Debra Goodwin. The motion carried. The HRA reentered closed session at 2:15pm. The motion was made by Debra Goodwin to enter closed session and was seconded by Dolores Sheen. The motion passed. The HRA entered closed session to discuss confidential information about current cases. The HRA returned to open session at 3:24 having taken no action in closed session. The motion to return to closed session was made by Debra Goodwin and seconded by Dolores Sheen. The motion carried.
