Hi George and Mike,

I don't have a copy of the final application. I'm taking the following from Attachment 4, second page.

RUMC, Rush Copley and Rush Northshore were all part of an obligated group when the Master Design application was filed. Both Rush Copley and Rush Northshore had to be included as co-applications because of the debt obligations they had for the project as part of the obligated group. This debt obligation is only relevant to projects financed with debt.

The Entry Pavilion project has no debt involved--so there is no need to include Rush Copley and Rush Northshore as co applicants. Check the Rush Copley applications--they are not financed with debt so RUMC is not a co applicant on their applications.

Further, Rush Northshore was acquired by NorthShore University Health System and they are no longer part of the obligated group--this change of ownership removed them from the role of co applicant on any RUMC applications.

Does this answer your question? If not, let me know what else you may need. Or let me know if you have any other questions that I can help you with.
