People who don't have insurance in the South Suburbs go to Oak Forest because there is no other hospital in the South Suburbs that can offer them full service continuity of care from X-Ray to Lab to Primary Care to hospitalization.

The other Hospitals don't refuse to see you when you are uninsured, but you don't get any continual care. It's service on the spot and then they tell you to follow up with your doctor in 3 days or to go to Oak Forest. A lot of times you can't get the medication prescribed at the other ER's because of the cost

Closing the Oak Forest ER and acute care hospital at this time will lead to an overcrowding at the Provident and Stroger ER's and hospitals. 


