Thanks for the help Mike,

In order to avoid any unnecessary efforts, the clients seemed amenable to not holding a public hearing for Streamwood to the extent that they would be able to submit or present information in support of the Streamwood application. As a result, to the extent we can or cannot do the following, we may be able to avoid the necessity of rescheduling and holding an additional public hearing:

- 1) Could the patients/presenters give their testimony as part of the applicant's presentation before the Board;
- 2) To the extent that these parties must present as public commentators prior to the applicant's presentation, will they be given any consideration in terms of length of their presentation since the public hearing was cancelled; and
- 3) Is it possible to carry over the testimony from the Oak Brook public hearing to the Streamwood public hearing?

Any help you can provide in obtaining this information would be greatly appreciated.
