
Dear Ms. Avery:

On behalf of Vista Surgery Center we are requesting Mr. Galassie consider exercising his discretion as chair to approve the above referenced application, subject to its presentation for questions by Board members at the upcoming February 28, 2012 meeting, when it is scheduled for consideration. The change of ownership relates to a corporate change of structure and the current owner/operator (Waukegan Illinois Hospital Company, which also owns and operates Vista East and West Hospitals) will remain in control of the Surgery Center. The new corporate structure will allow for physician investment. However, again the current owner will remain in control and hold majority interest. No policies or procedures or service changes will occur.
