Dear Mr. Seidler:

I am writing on behalf of RSC Illinois, LLC d/b/a Regional Surgicenter (“RSC”) located at 545 Valley View Drive, Moline, Illinois. As you are aware, RSC has filed a certificate of need application with the Illinois Health Facilities and Services Review Board (“HFSRB”) to add otolaryngology (“ENT”) procedures to its current multi-specialty ambulatory surgical treatment center (“ASTC”).

Regional Surgicenter is an existing ASTC with eight rooms. The addition of otolaryngology procedures will allow Dr. Thane Cody to perform ENT procedures at Regional Surgicenter. It will not result in any expansion or modernization of the existing surgery center. The cost of the proposed project will be approximately \$50,000. Regional Surgicenter projects the ENT caseload for the first year after project completion will be approximately 410 cases. None of these cases are currently being performed at facilities in the Illinois Quad Cities of Moline and Rock Island.

At this time, it would be useful if you can indicate to us whether Trinity supports or opposes this proposal or whether it will maintain a neutral position.

Please let us know whether you need to discuss this matter prior to responding.


