Re: Opposition to HFSRB Project Number 11-111.

Dear Ms. Avery:

Please accept this letter as opposition to the above referenced project. According to Illinois Health Facilities and Services Review Board's rules per Section 1130.130 Purpose, the objective of the health facilities planning program is to, in part, control the increase of health care costs; maximize the use of existing health care facilities and services that represent the least costly and most appropriate levels of care; and minimize the unnecessary duplication of health care facilities and services. To accomplish these goals, the proposed project should not be approved.

Specifically, the proposed project is and proposes to remain a tenant of Oak Brook Medical and Surgical Center located at 2425 West 22nd Street, Oak Brook, Illinois. Also, not only in the same building, not only on the same floor, but immediately adjacent and connected to the proposed project is, Oak Brook Surgical Centre a four operating room fully licensed multi-specialty ASTC which includes Obstetrics/Gynecological Services. The proposed applicant was originally provided the space adjacent to the ASTC with the intent for the practice to utilize the ASTC for its procedures. Towards that extent, operating room number three (existing ASTC) was built and designed with a window directly into the proposed applicant's endocrinology laboratory (then physicians IVF practice's IVF laboratory). Therefore, if the applicant is granted a permit to perform surgery at this location, it will negatively impact my facility.

The applicant of this project, Oak Brook Fertility Center, Ltd d/b/a The IVF Surgery Center at RMI appear to be disingenuous in addressing the Board's criteria that results in the misinforming the Board and its staff. Further, reasons for this objection and for above presumption please note the following:

1. On page 102 of the subject application, the applicant stated that: "The IVF Surgery Center at RMI is a fully completed center that is currently operational. The Village of Oak Brook, Illinois issued an occupancy permit on March 31, 2011." This statement seems to indicate that this applicant is operating without a permit and therefore would be considered in violation of the Ambulatory Surgical Treatment Centers Act and the Planning Act of the Health Facilities and Services Review Board.
2. Starting on page 138 of the certificate of need application it is repeated over and over that "the purpose of the proposed center is to combine existing Assisted Reproductive Technology (ART) centers into a single ART center licensed as a ambulatory surgical treatment center." This combination of services is admirable however, the applicant left out the fact that Dr. Paul Dmowski and his practice at the subject location has an existing arrangement with the ASTC, The Oak Brook Surgical Centre, which is adjacent and connected to the Reproductive Medicine Institute, LLC offices. Specifically, one of the existing ASTC's four operating rooms is immediately adjacent to the physician's endocrinology lab (proposed and existing) and is connected by a pass through window to the applicant's endocrinology lab as it was originally designed to accommodate this purpose. Therefore, the purpose for this project appears to be more for profit than the altruistic rationale that was presented.
3. Starting on Page 140 of the certificate of need application, the applicant cited one alternative of "contracting to use other facilities in the area". They continue: "However, most of these are close to physicians other than those who own the facility. The remaining facilities charge increased prices which add cost for the practice and the patient." Regardless of not following the rules and the application form for this section to provide and document the issues of "cost, patient accessibility, quality and cost benefit" the Applicant never discloses the fact that adjacent and contiguous to the proposed project is an existing ASTC that it has an existing relationship with. For your convenience appended hereto is a floor plan of the proposed project as it relates to the location of the existing ASTC. It should also be noted that Oak Brook Surgical Centre's fourth operating room is adjacent and connected to the proposed project's endocrinology laboratory as originally designed to accommodate the needs of the fertility practice. Therefore, it would appear that by utilizing the adjacent ASTC would represent an alternative with little to no cost.

4. On page 142 of the certificate of need application the applicant states that it is in conformance with the project services utilization. Although this applicant states that they meet this standard of 1,500 hours per operating room, it clearly does not understand this criterion. This standard as your staff will aptly point out is that in the second full year of operation, the proposed facility will meet the requirements of performing 1,500 hours of surgery per operating room. This project is proposing two rooms. Thus, it should have a reasonable plan to achieve 3,000 hours and it only states that it could meet 558 hours. Therefore, it would appear that this project is not needed as presented.
5. On Page 142 of the certificate of need application, the applicant states that they have a Geographical Service Area of 2 hours and 25 minute to the North, 1 hour and 40 minutes to the South, 2 hours and 12 minutes to the East and 1 hour and 40 minutes to the West. This appears to be unrealistic especially considering that the rules for this criterion limit the geographical services area to between a minimum of 30 minutes travel time to a maximum of 60 minutes travel time. This also seems a bit disingenuous as the Applicant implied on page 140 of the subject application under the alternatives criterion that its patients from DuPage County have to travel to Evanston and that was a good distance; Now under a new section of the application they are proposing to attract patients from Madison, Wisconsin down to Oak Brook, which is located in central DuPage County.
6. On Page 144 of the certificate of need application, the applicant lists seven facilities that it may have impact on. This list is rather short considering the lofty geographical service area that it desires and the number of existing ASTC's within the area. Appended herein is a Mappoint (software) listing of all facilities within a 30-minute travel time in accordance with the minimum service area size of this Board's rules. This list, without qualifying each facility with a MapQuest online search of each facility, finds 53 ASTC's within the minimum 30-minute travel time contour. There are 87 ASTC's preliminarily identified within the State's 1-hour travel time contour (this listing is also appended herein).

The above six items are the most glowing of the misinformation that was provided. Cumulatively, this information creates the portrait of an applicant who does not know or understand this process and has attempted to circumvent the process with the application and information provided. Please do not misunderstand me, I do not question this applicant's knowledge and ability to provide quality fertility care, but there is not a need for the project in terms of needing its own ASTC or does it show the capacity to be able to deliver a licensed surgery center in compliance with the rules and standards that govern such a facility. I respectfully submit that this Applicant has omitted the alternative of utilizing the adjacent and connected ASTC to the proposed project. Oak Brook Surgical Centre has the capacity to

accommodate this applicant (please refer to the ASTC's IDPH Annual Facility Questionnaire form enclosed herein) and has expressed to the applicant its desire to work with them in their ultimate endeavor of combining the resources to comprehensively provide reasonably priced fertility care center. Therefore, I am opposing this project at this time as it will definitely negatively impact Oak Brook Surgical Center.




