This firm represents USRC Bolingbrook, LLC (the "Applicant") in the above referenced matter. The USRC Bolingbrook, LLC certificate of need ("CON") permit is set to expire on August 1, 2012.

Modernization of the leased space for the U.S. Renal Care Bolingbrook Dialysis facility is currently on hold due to landlord delays in preparing the leased space for occupancy. Currently, the Applicant is awaiting construction of a firewall, installation of smoke detectors in fire ducts, sprinkler system repairs and completion of other landlord obligations. The Applicant anticipates that modernization will proceed once such matters are addressed by the landlord.

The project components yet to be completed include modernization of the leased space and installation of furniture, fixtures and equipment. To date, the Applicant has expended approximately \$51,364 on this project.

The Applicant has confirmed that the project's costs and scope comply with what Illinois Health Facilities and Services Review Board has approved and that sufficient financial resources are available to complete the project.
