Please be advised that no adverse actions as defined under 1130.140 have been taken against the Applicants, (Shorewood Investments I LLC, Alden Estates of Shorewood LLC, and Alden Courts of Shorewood, Inc.) within three years preceding the filing of the Certificate of Need application.

There are a few other Alden facilities that have received violations at the "A" level from the Illinois Department of Public Health. Notably, there are 33 Alden licensed long term care facilities in the State of Illinois. Since March of 2009, only eight of those facilities have received level "A" violations. Attached is a certified listing of the facilities with level "A" violations, as well as a list of Alden facilities that have had no type "A" violations filed against them within the past three years.
