Enclosed are two letters that did not arrive in our office in time to be included in our letter of August 21.


It is possible that you have already received these letters, since they may have been sent directly to Chairman Galassie. Nevertheless, I wanted to pass them on to you.

Dear Mr. Galassie:

This letter is intended to support the development of ManorCare Health Services of Crystal Lake, a 130-bed post-acute skilled nursing center to be located in McHenry County.

I serve McHenry County residents and am well aware of the needs of the local community, the growth of the population in the area and, and specifically, the need for additional skilled nursing services. The 2010 McHenry County Healthy Community Study indicates that there is a "lack of sufficient nursing home options in the county" and we agree with that assessment. In the past year, I have made 15 referrals to LTC facilities in the area.

I estimate that I can refer approximately 2 patients per month to this new Manor Care SNF. To be clear, I recognize that this is only an estimate of referrals that could be made. It is difficult to assess circumstances two to three years in advance, so this is not a commitment, but it is a recognition that a new provider is needed to serve the growing population and that HCR-ManorCare provides a program of care that we support.

None of these projected referrals have been provided to anyone else for use in a CON application.
