**Re: Petition to Intervene in Administrative Hearing  
ManorCare Health Services of Crystal Lake (Project No. 12-039)**

Dear Ms. Avery:

We represent The Springs at Crystal Lake (the "Springs"), Fair Oaks Health Care Center ("Fair Oaks"), and Crystal Pines Rehabilitation and Health Care Center ("Crystal Pines") (collectively, "Intervenors"). Intervenors each presented opposition to Project #12-039, ManorCare Health Services of Crystal Lake's application to establish a new 103 bed facility (the "Project"). Written comments of opposition were submitted to the Health Facilities and Services Review Board (the "Board" or "HFSRB"). Additionally, Intervenors submitted comments in response to the staff report and presented oral testimony before the Board opposing the Project.

Intervenors each qualify as adversely affected persons as defined by 77 Ill. Admin. Code 1130.1040(e). Specifically, each are existing health care facilities located in the Health Service Area ("HSA") where the Project is proposed and provide services similar to those of the applicant. See Section 1130.1040(e)(5). Therefore, in accordance with 77 Ill. Admin. Code § 1130.1070, Intervenors hereby petition the Board to intervene in the above-referenced matter.

Intervenors' grounds for intervention are fully detailed in the written comments submitted to the Board and the testimony offered before the Board. In summary, Intervenors would be adversely affected by approval of the Project because the Project is not in substantial conformance with the Board's regulations and fails to comply with the criteria identified within the Health Facilities Planning Act, 20 ILCS 3960, and regulations promulgated thereunder. Furthermore, as existing facilities within the HSA and, given the abundance of underutilized facilities in the planning area, the proposed Project would have a substantial impact upon these

facilities, result in unnecessary duplication of services, yield maldistribution of services within the HSA, and negatively impact overall accessibility of services.
