

**SUPPLEMENTAL INFORMATION FOR
#12-055 Fresenius Medical Care Lockport**

In response to the Intent to Deny issued to project #12-055 at the December 10, 2012 meeting, Fresenius Medical Care is submitting this additional information and requests the Board to reconsider its decision based on the following information.


The project will not cause maldistribution of services according to the ratio of stations to population in the Lockport area, which is **1 station for every 7,611** residents as listed in Attachment 26c of the application. There are more than double the numbers of residents per station than the State average of 1/3,250. The fact that there is an excess of stations in HSA 9 despite the lack of stations for the population in Lockport is due to the distribution of the population in HSA 9. The map below shows the population distribution in HSA 9 which includes Will County where Lockport is located.



The map clearly shows that the highest population density lies in the northeast portion of HSA 9 and more specifically the northern half of Will County bordering Suburban Cook and DuPage Counties (HSA 7) where there is a need for an additional 51 stations. Because of its proximity to HSA 7 the facility will also serve 30 patients identified from Lemont, which is just over the border into HSA 7.

HSA 9 had 1,171,557 residents in the zip codes that were mapped according to the 2010 census. One-third, or 615,378, of the HSA population is found in northern Will County, where the Lockport clinic is proposed.

With the population density there is an increased prevalence of end stage renal disease patients requiring additional stations for the area. The map below shows the location of ESRD patients in HSA 9, which is similar to the distribution of the general population. There are 1,057 ESRD patients represented for all of HSA 9 and **half (519) reside in the northern half of Will County.** There are a few pockets of patient population density in each of the 3 remaining counties.

HSA 9 added a total of 257,630 residents to its population between 2000 and 2010 according to the 2010 census for a total growth of 37%. **The majority of this growth, 68%, occurred in Will County, which added 175,294 residents.**

Included in this population boom was a dramatic growth in the Hispanic population. Those of Hispanic descent are twice as likely to develop diabetes and hypertension which are the two main causes of kidney failure. The Hispanic population in Will County doubled while the Hispanic population of Lockport itself tripled from 2000-2010.

We encourage the Board to consider these conditions that are unique to the northern half of Will County in HSA 9 along with the travel difficulties Lockport residents face as previously stated in the application, at the December 10th Board meeting and as referenced on the following page.
