Dear Dr. Hasbrouck:

I want to update you on the status of Maryville Behavioral Health Hospital ("Hospital"). As you know, I informed you on April 4, 2014, that Maryville Academy ("Maryville") had filed an application to discontinue the operations of the Hospital with the Illinois Health Facilities and Services Review Board ("IHFSRB"). Our application to discontinue is still pending before the IHFSRB and is scheduled for a hearing on July 14, 2014.

However, during the time period since we filed our application, Maryville Academy has received an offer to purchase the hospital. We have retained Ms. Clare Connor Ranalli and the law firm McDermott, Will and Emery to represent Maryville in our negotiations with the potential buyer. As of today's date, the negotiations are proceeding but no definitive asset purchase agreement has been concluded. If these negotiations are successful, the buyer has represented to Maryville that they will apply for hospital licensure and continue to operate the hospital as an acute care facility providing inpatient behavioral health services. The buyer is very aware of the required legal and regulatory steps necessary in order to have the IHFSRB approve the change of ownership of the Hospital. The buyer is also aware of the need to submit a request for a change of ownership to IDPH licensing division, and to request a provider number from the Department of Healthcare and Family Services.
