NOTICE OF A 2nd PUBLIC HEARING AND WRITTEN COMMENT

The Illinois Health Facilities and Services Review Board ("State Board") is giving notice of a 2nd public hearing for Project #14-043 St. Elizabeth Hospital for the discontinuation of a 303 bed acute care hospital located at 211 South Third Street, Belleville, Illinois and the establishment of a 144 bed acute care hospital to be located at the intersection of Interstate 64 and North Green Mount Road, O'Fallon, Illinois at a cost of \$253,471,535.

The public hearing will be held on November 18, 2014 at the Belleville West High School - Commons/Cafeteria, 4063 Frank Scott Parkway West, Belleville Illinois. Sign in to provide public testimony will be from 4:30 - 5:00 p.m. The public hearing will begin at 5:00 p.m. and will conclude at 7: 00 p.m.

Consideration of Project #14-043 by the State Board has been scheduled for the **December 16, 2014, State Board Meeting**. Any person wanting to submit written comments on this project must submit these comments by **November 26, 2014**.
