Dear Mr. Constantino,

My name is Dr. Phil Silsby, -a retired educator who presently serves as an Alderman of the Ward where St. Elizabeth's Hospital is currently located. Furthermore, I am writing as a citizen of Belleville, a family member of someone who has used the current facility, and as a community leader. As you can see I have a vested interest in seeing St. Elizabeth Hospital stay in its current location.

This hospital has been an important part of this community for a very long time. It has served our community and surrounding communities with exceptional care during times of direst. My mother was a patient in the hospital many times. Her condition at times was critical. Meaning that traveling to the closest hospital was necessary in order to care for her immediate needs. Had St. Elizabeth's not been located where they are, the extra travel could have been a life or death situation.



Many institutions in our area especially Belleville have taken outdated facilities and turned them into functioning and up-to-date structures that bring a sense of pride to their operation and the city of Belleville. As a community leader, I am quite willing to help St. Elizabeth's secure and maintain a state-of-the hospital at its current location.

Considering all of these factors mentioned above, I urge the Health Facilities & Services Review Board to DENY St. Elizabeth's Hospital a certificate of need for a new facility in O'Fallon, Illinois. Thank you for your time and consideration of these heartfelt thoughts.
