Mr. Constantino:

I am writing to express my strong opposition to the proposed move by St. Elizabeth's Hospital out of Belleville, IL. The proposed move is detrimental in a number of key ways:

- Moving St. Elizabeth's Hospital north and east of its current location will leave the southern part of its current service area grossly underserved. The burden of care will fall to nearby hospitals Memorial (Belleville) and Touchette Regional (Centreville), which do not have the capacity to cover the void that would be left should you approve the location of St. Elizabeth's. The move would also create a surplus of beds in an area where many wealthier residents seek care in St. Louis rather than from local hospitals. Much of the area St. Elizabeth's would be abandoning is generally less wealthy, and therefore has less access to hospitals outside the immediate area—a population that depends most heavily on the services St. Elizabeth's provides and would be most at risk should you approve St. Elizabeth's proposed move.
- St. Elizabeth's does not have a reasonable or responsible plan for the infrastructure they will abandon should you approve their move. There is a considerable amount of vacant or underutilized space in the vicinity of the current location that could be utilized to reconfigure their current facility. Should you approve their plan to abandon their present location, they have no clearly defined plan to help repurpose the current facility. This will create an undue hardship on the surrounding community and blight in the heart of the city of Belleville.
- St. Elizabeth's has been providing care at its current location for generations. This community has supported St. Elizabeth's for generations. Please help us keep our hospital so that we can work together to keep both the hospital and our community viable.

I can't imagine that you haven't heard every argument there is for the relocation of St. Elizabeth hospital in Belleville. I'm going to give my 2 cents anyway.


