I currently go to Mercy Hospital in St. Louis County for my care because the hospital is a much more modern facility than St. E's is. My perception is that Mercy's equipment is newer and better and the doctors are probably better. I know if I was a doctor, I would much rather work at a modern hospital rather than an older, outdated facility such as St. E's downtown Belleville location so I think St. E's will attract better doctors if they are allowed to construct their new facility in O'Fallon IL. I will be a patient in their new hospital if it gets built in O'Fallon, I won't be a patient of theirs if they stay in Belleville.

The Metro East area doesn't have a modern facility such as their proposed hospital, it is much needed so people like I will stop going to St. Louis for care. Memorial's "satellite" hospital isn't full service, I won't go to it. I won't go to Memorial hospital in Belleville because it's not on the Interstate and is very difficult to get to.
