2. Please provide the physicians' specialties that will have offices at the medical clinics building. Are physicians going to be relocated from Belleville to Shilo?
3. Please provide a site plan in readable format.
4. Please provide a complete narrative by floor (including basement) of what is going to be provided in the medical clinics building. If schematics are available in readable format that would suffice.
5. Please provide a revised cost space chart that includes space based upon the narrative in the application. If our understanding is incorrect please correct the Table below.
6. Additionally the Table in Attachment 39 needs to be revised to reflect the changes below.
