

On October 30, 2012, the Illinois Health Facilities and Services Review Board approved your request for a change of ownership for the referenced project based upon the project's substantial conformance with the applicable standards and criteria of 77 Ill Adm. Code 1130.520. In arriving at a decision, the State Board considered the findings contained in the State Agency Report, the application material, public hearing testimony and documents, any testimony made before the State Board, and the Illinois Health Facilities Planning Act (20 ILCS 3960).

- **EXEMPTION: #E-005-12 –The Glen Endoscopy Center** – The permit holder is approved for a change of ownership of a limited specialty ambulatory surgical treatment center located at 2551 Compass Road, Suite 115, Glenview, Illinois. The operating entity is The Glen Endoscopy Center, LLC and the owner of the site is the aug Five, L.P. c/o Titan.

- **EXEMPTION AMOUNT:** \$7,993,850

You are reminded that this exemption is valid for only 12 months from the date of approval and is not transferable or assignable. This exemption must be completed within the 12 month period. To demonstrate completion of this transaction the exemption holder must provide the State Board with the date that the ownership change occurred and also provide a copy of the license or certification issued pursuant to the change of ownership. Failure to provide the required notification shall subject the exemption holder to the sanctions provided under Section 14 of the Illinois Health Facilities Planning Act. The exemption holder is also reminded that 77 Il. Adm. Code 1130.140 defines transactions that constitute a change of ownership of a health care facility. You should become familiar with those definitions.


