General duties: A Registered Nurse I, under general supervision, and in conformance to established standards, performs duties of a professional nature related to nursing follow-up services for children identified with elevated blood lead levels; coordinates the provisions of prevention and intervention activities with local health departments, health care providers, regional Public Health staff and parents.

The requirements for a minimal passing grade are as follows:

Training and Experience: Graduate from an approved nursing education program, plus possession of a valid Illinois license as a registered nurse.

**Illinois Registered Nurse license number must be submitted with application.**

A higher grade may be obtained for this title if:

- 1) Required license was earned within 5 years of the date graded; OR
- 2) Required license was earned over 5 years from the date graded and applicant lists sufficient related experience demonstrating currency in the field.

Tests and weights: Training and experience 100%.

## **REGISTERED NURSE I**

Length of eligibility period: One year.

Option MC - Manual Communication Skills: At the time of the job interview, the eligible will be required to exhibit the ability to communicate effectively with the deaf by utilizing American Sign Language concepts and manual communication skills. Failure to exhibit these abilities will result in disqualification for this option.

Option PO – Slavic (Polish) Speaking: At the time of the job interview, the eligible will be required to exhibit the ability to understand and speak Slavic (Polish) and English fluently. Failure to exhibit this ability will result in disqualification for this option.

Option SS - Spanish Speaking: At the time of the job interview, the eligible will be required to exhibit the ability to understand and speak Spanish and English fluently. Failure to exhibit this ability will result in disqualification for this option.

Counties in which positions are established: Adams, Clinton, Cook (MC) (PO) (SS), Kane, Kankakee, Lake, LaSalle, Lee (MC), Livingston, Madison, Morgan (MC), Randolph, Sangamon, Union.

(MC) Indicates Manual Communication Option is also established in that county.
