General duties: A Registered Nurse II functions independently in providing professional nursing care in emergent and non-emergent situations to employees and visitors at various locations; provides direct nursing care by performing patient assessments, nursing interventions, administering medications (oral, injections and topical) monitoring patients' chronic conditions, administering emergency nursing care, and counseling patients on health related problems; teaching/coordinating preventive and/or specialized health programs; coordinating appropriate referrals to physicians and/or services as indicated by patients' condition and health care coverage; prepares patient related correspondence, monthly reports, accident reports, building manager reports and maintains accurate patient records; orders and maintains supplies for station.

The requirements for a minimal passing grade are as follows:

Training and Experience: Possession of a valid Illinois license as a registered nurse plus:

- a) Associate or Diploma degree in nursing and two years of progressively responsible professional nursing experience; OR
- b) Bachelor's degree in nursing and one year of professional nursing experience.

Illinois Registered Nurse license number must be submitted with application.

Tests and weights: Training and experience 100%.

Length of eligibility period: One year.

Option MC - Manual Communication Skills: At the time of the job interview, the eligible will be required to exhibit the ability to communicate effectively with the deaf by utilizing American Sign Language concepts and manual communication skills. Failure to exhibit these abilities will result in disqualification for this option.

Option SS - Spanish Speaking: At the time of the job interview, the eligible will be required to exhibit the ability to understand and speak Spanish and English fluently. Failure to exhibit this ability will result in disqualification for this option.
