**TELECOMMUNICATOR TRAINEE - 45325**

Monthly Salary Range: \$3124 - \$4402

General duties: A Telecommunicator Trainee participates in an agency sponsored training program for a period not to exceed twelve (12) months in Law Enforcement Telecommunications applications designed to develop familiarization with the usage of two-way radio, teletype and computer equipment.

Desirable training and experience: High school graduation; or any equivalent combination of training and experience.

Knowledges tested: Written Instructions; Interpersonal Skills; English Usage; Map Reading; Taped simulated emergency dispatches testing mental recall and mental recall amidst distraction.

Tests and weights: Automated multiple-choice test weighted 43% and performance test weighted 57%. A candidate must also pass a qualifying typing test from copy at a net rate of 30 words per minute.
